1.		Be empathetic to the member's situation.	
2.	Personify	Look up the customer's policy information.	
3.		Give the customer the policy number and offer to "warm" transfer them to the Claims department.	

Note: Make sure to offer the phone number in the event they get cut-off in the transfer.
